## Objective of the expressions of interest

The main objective of this invitation is to compile a database of consulting companies interested in providing consulting services required for the planning, monitoring and implementation of Phase I Field Development for the subsequent international public bidding to be conducted under the norms of the Japan International Cooperation Agency (JICA).

## **Project Description / Scope of Consulting Services**

The Ecuadorian Government, through CELEC EP (the Ecuadorian Electric Corporation) with the financial support of the Japan International Cooperation Agency (JICA), will obtain an Official Development Assistance (ODA) credit to undertake the procurement of consulting services for Phase I: Field Development for the Chachimbiro Geothermal Project.

With Phase I, it is expected that the geothermal resource will be characterized to carry out the basic design and prepare the final stage for the construction of a 50 MW geothermal plant in Chachimbiro.

The contributions from the Japanese cooperation will be destined to the contracting of a Consulting company to conduct the engineering, monitoring / provisioning / supervision / inspection of the drilling services, and the construction and commissioning of a wellhead plant of up to 5 MW. It is expected that at the end of the service, all the documentation and planning to procure and execute the construction phase of the 50 MW geothermal plant will be complete.
